The Gold Line Foothills Extension is a 23.9-mile extension of the Metro Gold Line light rail corridor from its former terminus in Pasadena, California, east through the "Foothill Cities" of Los Angeles County into San Bernardino County. The corridor extension forms a part of the Los Angeles County Metro Rail system.

Mr. Quintanar's Role: Fire, Life, Safety and Security Consultant

On the Azusa to Montclair Extension, John is a member of the Fire, Life, Safety and Security Committee, working closely with first responders. He co-developed an emergency plan for the 12 miles of alignment, ensuring the plan complied with Metro Criteria and NFPA 130. Additionally, he co-designed an emergency plan for first responders that identified key areas throughout the alignment and helped initiate MOU with all first responders.

On the Pasadena Gold Line Extension Light Rail Project, John worked closely with Fire Responders on 2 underground stations, updating and training Responders on the rail system. He worked with the design team to approve the alignment and the Maintenance facility. Once the design process was approved, he worked closely with the contractor to witness construction of the project.
